Therefore, Area I, as described in the Declarations, shall include Section Nine (9) recorded under Film Code No. 379047, Section Ten (10) recorded under Film Code No. 377143 and Section Eleven (11) recorded under Film Code No. 381077, all in the Map Records of Harris County, Texas. Said Section One (1) was subject to the Declarations and therefore Sections Nine (9), Ten (10) and Eleven (11) are subject to the Declarations and are part of the defined term Property as set out in Article I, Section 1, Paragraph (m) of the Declarations.

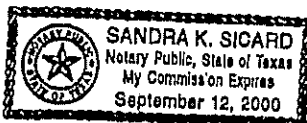
